Monthly activities

LSO Ittefaq Welfare Organization, Shirkot Kohat has done a number of developmental activities during the month according to plan, which are mentioned below:

- LSO formed 03 PWDs MCOs and 03 PWDs WCOs in U/c Alizai under LCDDP project. The project is being implemented in 03 U/Cs Shirkot, Alizai and Usturzai through Ittefaq LSO. The project is regarding the welfare and rehabilitation of PWDs in target U/Cs. After group formation a plan for skill training will also be launched for PWDs.



- VO Shirkot passed a resolution against low voltage and sent it to the LSO. The LSO called a meeting for solution of VO Shirkot problem. LSO requested WAPDA and SDO to attend the meeting and in order to listen to the VO's problem. LSO invited VO members, as well as the Minister of Revenue, Sayed Qalb e Hassan who is the representative for PK 38 in the Khyber-Pakhtunkhwa Assembly. They attended

the meeting however Sayed Mehtab ul Hassan (brother to the Minister) was the substitute for the Minister who could not attend the meeting due to an Assembly session. WAPDA officers briefed the VO members about low voltage. They ensured that if 03 transformers of 500 KV were provided then the issue would be solved. Sayed Qalb e Hassan promised that he would forward the LSO's demand to the Minister and that he would provide the required transformers as soon as possible.



- A project of DTCE regarding local Government system is being implemented through Khushal Awareness and Development Organization in 32 U/Cs of Kohat. A Delegation Committee was formed in each U/C and KADO provides them with financial assistance of Rs.15000/- PKR quarterly through that project. DTCE selected Ittefaq LSO out of 5 organizations for project monitoring. A MoU was signed between DTCE and Ittefaq LSO. LSO Executive committee nominated 5 members as its monitoring team.



- LSO distributed Food Items amongst the poorest families through NET PAWO in the LSO Office. The package was named "Ramazan Package". LSO members and

- With Collaboration of FPAP, the LSO celebrated “World Youth Day”. Members of Youth Organizations, LSO members and community members participated in a Seminar. FPAP Program Manager Ajmal Khan, SO Zubir Parach and Chairman Ittefaq LSO Isar Ali Bangash briefed the participants about youth related issues.



- NET PAWO M&E Regional Officer Muzamil Shah visited the LSO office and met with LSO Executive Committee members. The agenda was to run a cleaning campaign in U/C Shirkot. LSO members agreed to work with NET PAWO for awareness and development of the community.



- Minister of Revenue Khyber Pakhtunkhwa, Sayed Qalb e Hassan distributed wheelchairs among PWDs through the LSO. The LSO completed a survey to identify PWDs in 3 U/Cs of Shirkot, Alizai and Usturzai resulting in the fact that the LSO was contacted by individuals and NGOs who wanted to work for the welfare of PWDs. The LSO has lists of PWDs and what assistive tools/devices they require; all generated through the LSO's survey of PWDs. Thus it ensures that each PWD receives the correct assistive tool/device.



- Chairman Ittefaq LSO Isar Ali Bangash nominated a member of the District Supervisory Committee for the distribution of the rehabilitative aids to the physically-challenged people. A notification was issued from DCO Kohat office in which the DCO notified after the recommendation of District Assistant Board Kohat, comprising of the following.
